3. The individual selection behavior of risk decision oriented: the complexity characteristics, evolution mechanism and evolution rule from individual selection behavior to group selection behavior.

4. Complexity economic systems: Macro-economic system, enterprises development and structure, manufacture and supply network, recycling economics, sustainable development theory, technical economics;

5. Complexity financial system: system science finance theory, behavior finance theory, financial risk management, optimization and simulation of complexity financial system, credit management, macro-micro financial regulation, financial system management, internet finance;

6. Complexity society system: social governance, public management, emergency management;

7. New Media Research: social network, information dissemination, information dissemination behavior of social media, moral hazard and so on;

8 Energy Problems: water resource management, smart power grid, transaction behavior of electricity market.
